# MINUTES NEW BOSTON VILLAGE COUNCIL March 2, 2021

Regular meeting was called to order at 6:40 P.M., which was held by Zoom. William Williams, President of Council presided over the meeting. The roll was called with the following members of council being present: Mr. Fetty, Mr. Mills, Mr. Ottney, Mr. Imes, Mr. Mills and Korey Jones.

#### Pledge of allegiance/silent prayer

**Disposal of minutes** – Mr. Mills made a motion to accept and file the minutes from February 16, 2021 and special meetings February 13 and February 23, 2021. Mr. Meehan made a motion to amend the minutes from February 13 to change pm to am. Mr. Mills seconded the motion. All members concurring, Mr. Williams declared the motion carried 6-0. Mr. Mills made a motion to accept and file the minutes and Mr. Ottney seconded the motion. All members concurring, Mr. Williams declared the motion carried 6-0.

Reports from committees, delegations, citizens or visitors: Randy Yohe asked if the resolution regarding the contract with Kester could be explained and another comment asking about the flooding. Mayor stated he would report on the flooding and Mr. Blume could comment on the contract with Kester. Mayor reported all pumps are running but we did lose electic to stations 8 & 9 and had to get generator from Ashland. Stations are being manned 24 hours a day. Minor stream flooding but everything looking good now. Mr. Blume stated the agreement relates to one of the two investigations involving former council member, Vonald Patrick. These investigations are to determine whether village policies were followed.

Reading and acting on communications: Received a letter from Melinda Burnside thanking the village for all the snow and ice removal. Mr. Ottney made a motion to accept and file and Mr. Mills seconded the motion. All members concurring, Mr. Williams declared the motion carried 6-0

Getting specs for the paving so we are working on the community development projects also. 3. Sending his

condolences to Steve Hamilton and family for the loss of his father. 4. Presented Mayor's court report. Mr. Mills made a motion to accept and file. Mr. Ottney seconded the motion. All members concurring, Mr. Williams declared the motion carried 6-0.

Mr. Fetty moved the rules requiring an ordinance or resolution of a general or permanent nature involving the expenditure of money be read of three separate dates be suspended. Mr. Mills seconded the motion. All members concurring, Mr. Williams declared the motion carried 6-0. Mr. Fetty made a motion to adopt Ordinance No. 10-2021. Mr. Mills seconded the motion. The roll was called. The voting results are as follows: ayes – 6-0

Ordinance No. 11-2021 – An Ordinance was read to approve then and now certificate in excess of \$3,000 for payment to Axon Enterprise, Inc.,; and declaring an emergency. Mr. Mills moved the rules requiring an ordinance or resolution of a general or permanent nature involving the expenditure of money be read of three separate dates be suspended. Mr. Meehan seconded the motion. All members concurring, Mr. Williams declared the motion carried 6-0. Mr. Mills made a motion to adopt Ordinance No. 11-2021. Mr. Meehan seconded the motion. The roll was called. The voting results are as follows: ayes – 6-0

Ordinance No. 12-2021 – An Ordinance was read amending sections 107.03 and 107.02 of the codified ordinances of the Village of New Boston; and declaring an emergency. Mr. Ottney made a motion to table this ordinance and bring in new ordinance to separate the items involved. Mr. Jones seconded the motion. The roll was called. The voting results are as follows: ayes - 3 (Mechan, Ottney, Jones) ayes - 3 (Fetty, Imes, Mills) Mr. Williams broke the tie with an aye vote just so everyone could be on the same page. Ordinance was tabled.

**Resolution 5-2021** — A resolution was read authorizing the Village Administrator to enter into an agreement with J.H. Kester Company; and declaring an emergency. Mr. Mills moved the rules requiring an ordinance or resolution of a general or permanent nature involving the expenditure

of money be read on three separate dates be suspended. Mr. Meehan seconded the motion. All members concurring, Mr. Williams declared the motion carried 6-0. Mr. Mills made a motion to adopt **Resolution 5-2021**. Mr. Meehan seconded the motion. The roll was called. The voting results are as follows: ayes - 6
