Reading of Ordinances and Resolutions

Ordinances:

Ordinance No. 28-2021 — Second reading was given to an ordinance authorizing the issuance of a permit to New Boston Basketball to solicit charitable contributions from occupants of motor vehicles on a highway pursuant to a permit to be issued by the clerk at the direction of council; and declaring an emergency. Mr. Mills moved the rules requiring an ordinance or resolution of a general or permanent nature involving the expenditure of money be read on three separate dates be suspended. Mr. Jones seconded the motion. All members concurring, Mr. Williams declared

the motion carried 6-0. Mr. Mills made a motion to adopt **Ordinance No. 28-2021**. Mr. Meehan seconded the motion. The roll was called. The voting results are as follows: ayes - 6.

Ordinance No. 26-2021 — Third reading was given to an ordinance authorizing the issuance of a permit to the Bikers for Charity to solicit charitable contributions from occupants of motor vehicles on a highway pursuant to a permit to be issued by the clerk at the direction of council. Mr. Mills made a motion to adopt Ordinance No. 26-2021. Mr. Ottney seconded the motion. The roll was called. The voting results are as follows: ayes – 6.

1st Readings

Ordinance No. 30-2021 — An ordinance authorizing the operation of low speed under speed or utility vehicles. Mr. Jones stated he would like revise the ordinance to 35 mph and also a 3 year inspection instead of 1 year. Further discussion was held for either the 25 mph or 35 mph. Mr. Ottney made a motion for the 25 mph and Mr. Imes seconded the motion. The voting results are as follows: ayes – 3 (Mills, Imes, Ottney) nays – 3(Fetty, Jones, Meehan) Mr. Williams voted ayes to break the tie, therefore the ordinance will be brought in to reflect the 25 mph. Next discussion was either have a one year or a three-year inspection. Mr. Fetty made a motion to make it a three-year inspection and Mr. Jones seconded the motion. All members concurring, Mr. Williams declared the motion carried 6-0.

Ordinance No. 31-2021 — An ordinance was read transferring and appropriating amounts in the various funds of the Village; and declaring an emergency. Mr. Mills moved the rules requiring an ordinance or resolution of a general or permanent nature involving the expenditure of money be read on three separate dates be suspended. Mr. Fetty seconded the motion. All members concurring, Mr. Williams declared the motion carried 6-0. Mr. Mills made a motion to adopt Ordinance No. 31-2021. Mr. Meehan seconded the motion. The roll was called. The voting results are as follows: ayes — 6-0

Resolutions:

Resolution No. 14-2021 — A resolution was read granting a one-dollar hourly premium Covid-19 hazard pay increase to all emergency responders and dispatch employees; and declaring an emergency. Mr. Fetty moved the rules requiring an ordinance or resolution of a general or permanent nature involving the expenditure of money be read on three separate dates be suspended. Mr. Mills seconded the motion. All members concurring, Mr. Williams declared the motion carried. Mr. Mills made a motion to adopt Resolution No. 14-2021. Mr. Ottney seconded the motion. The roll was called. The voting results are as follows: ayes – 6.

Resolution No. 15-2021 — A resolution was read granting a one-dollar hourly pay increase to all service department employees, administrative personnel and office staff workers; and declaring an emergency. Mr. Mills moved the rules requiring an ordinance or resolution of a general or permanent nature involving the expenditure of money be read on three separate dates be suspended. Mr. Meehan seconded the motion. All members concurring, Mr. Williams declared the motion carried. Mr. Mills made a motion to adopt **Resolution No. 15-2021**. Mr. Jones seconded the motion. The roll was called. The voting results are as follows: ayes — 6.
